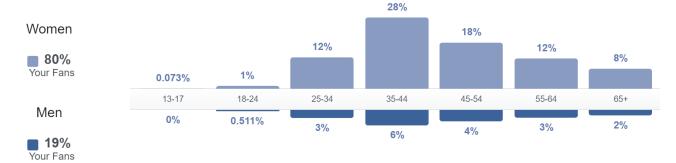

1. Why the change?

- a. All volunteers will need to complete an annual registration to confirm continued participation as a volunteer
- b. All volunteers will need to complete the fingerprinting process one time only
- c. All current volunteers will complete the process by appointment at designated locations throughout the county
- d. New volunteers will register during designated periods
- a. Special registration for special circumstances will be handled on a case by case basis
- b. January for Spring/Summer sports
- c. July for Fall/Winter sports

3. When will new process begin?

- a. Background checks for existing volunteers will be mid/late October March 2020
- b. Designated dates and locations and promotional materials will be provided
